## OFFICIAL TERMS & CONDITIONS

**1. Eligibility:** This sweepstakes is open only to those who like the official Ashley for the Arts page, like the post and comment on the original post and who are 13 years of age or older as of the date of entry. The sweepstake is void where prohibited by law.

**2. Agreement to Rules:** By participating, you agree to be fully unconditionally bound by these rules, in addition, you agree to accept the decisions of Ashley for the Arts as final and binding as it relates to the content of this sweepstakes.
